Custodian



Paula and I have been married thirty five years. Both my children and granddaughter went to school here.


After thirty six years at the Worland Sugar Factory and the daily commute, working here is a dream! Thanks Neysha for letting me know about the job opening!

The class for 4 year olds is Monday, Wednesday, and Friday from 7:58 A.M. to 11:00 A.M. The class for 3 year olds is Tuesday and Thursday from 7:58 A.M. to 11:00 A.M. If your child is 3 but not potty trained they may start whenever that happens. You will need to bring a birth certificate and immunizations records. In my spare time, I enjoy spending time outdoors with my husband, Alex, and our dog, Sonny. Together, we go hiking, fishing and skiing.




School Resource Officer

July 17, 2018

The Annual Budget meeting of the Washakie County SD #2 Board of Trustees was called to order at 7:02 p.m. by Chairperson Tessia Greet. Present were board members Tessia Greet, Jared Lyman, Terril Mills, Chuck Powell and Jane Thurston. Also present were Superintendent Jimmy Phelps, Business Manager Connie Gay, Janet Collen and Administrative Assistant Neysha Lyman.

Pledge of Allegiance was led by Chairman Tessia Greet.

Adopt Agenda: Chuck Powell moved to adopt the amended agenda with the addition of 7.a Discussion of High School Football and F.3 Executive session item Purchase of Property. Seconded by Terril Mills. Motion carried 5-0.

Security Assessment: Kurt Steinke reported to the board the results of the Security Assessment he conducted and answered questions.

Business (Consent Agenda Items): Minutes of the June 11, 2018 meeting were approved. Board members received copies of the statements and bills for review. Terril Mills made a motion to approve the consent agenda. Seconded by Chuck Powell. Motion carried 4-0. Jane Thurston abstained from check #21298 and 21318. Authorization to pay the following vouchers: General Fund warrants #21280-21323 in the amount of \$285,162.14; Federal Fund warrants #3860-3868 in the amount of 4878.48; Major Maintenance warrants # 1240-1241 in the amount of \$45,325.00; Hot Lunch Fund warrants #1460-1461 in the amount of \$704.80; Teacherage Fund warrants #1473-1479 in the amount of \$14,483.34; Activity Fund warrants #2732-2740 in the amount of \$1,868.20.

Discussion of High School Football: Ms. Novak and Mr. Phelps informed the board that there are not enough students for a High School Football Team. Ms. Novak will contact the teams that were scheduled and inform them. She will also contact Worland to work something out for the few boys who want to play.

Propane Bids: The district received three bids for propane for the school year 2018-2019. Chuck Powell made the motion to approve the bid by Big Horn Coop to provide our district with propane for the 2018-2019 school year at a price of \$1.299 per gallon. Seconded by Jane Thurston. Motion carried 5-0.

Concealed Carry by Employees Policy: Discussion followed.

Regular Meeting Was Adjourned: Chairperson Tessia Greet adjourned the regular meeting at 7:59 p.m.

Budget Hearing:

Budget Session started at 8:00 p.m. Chuck Powell moved to approve the Budget Appropriation and Levy Resolution: WHEREAS, on the 14th day of May, 2018 the budget officer filed with the Board of Trustees of Washakie County School #2 a tentative budget message for the fiscal year ending June 30, 2018 and

WHEREAS, a summary of the budget was entered into the Board Minutes, and a notice of a public hearing on such budget together with said summary was published in the Northern Wyoming Daily News, a newspaper having general circulation in the county in which the district is located, on the 10th day of July 2018, and notice was posted in three conspicuous places in the district; and

WHEREAS, a public hearing was held concerning such budget on July 17, 2018 at 8:00 p.m., at which time all interested parties were given an opportunity to be heard.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Washakie County School District #2 that such budget, as revised, if applicable, is hereby adopted and, subject to future amendments, is in effect for the fiscal year ending June 30, 2019.

BE IT FURTHER RESOLVED that the following appropriations are made as of and for the fiscal year ending June 30, 2019, and that those respective expenditures applicable to each department and fund shall be limited to the amounts hereby appropriated, subject to future amendment.

Terril Mills moved we hire Mr. Wilmer Zollman as a secondary teacher for the 2018-2019 school year, contingent upon passing all required background checks. Seconded by Chuck Powell. Chuck Powell moved to authorize the superintendent to make an offer to purchase property as recommended by the superintendent during executive session. Seconded by Jane Thurston. Motion carried 4-0. Jared Lyman abstained from the vote.
